

RE: Fair Work (Registered Organisations) Act 2009 Section 271 – Construction, Forestry, Maritime, Mining and Energy Union – Manufacturing Division – TCF Victorian District – Application for Exemption Certificate for year ending 31 December 2018

I am the Divisional National Secretary of the Construction, Forestry, Maritime, Mining and Energy Union – Manufacturing Division and occupied that position for the year ending 31 December 2018.

Pursuant to section 271 of the Fair Work (Registered Organisations) Act 2009, I hereby apply for a certificate of exemption for the TCF Victoria District in respect of the financial year ending 31 December 2018.

In support of this application I submit as follows:

- The Textile Clothing Footwear Union of Australia (TCFUA) and Maritime Union of Australia (MUA) amalgamated with the Construction, Forestry, Mining and Energy Union (CFMEU) to form the Construction, Forestry, Maritime, Mining and Energy Union on 27 March 2018 (amalgamation day).
- 2. Prior to amalgamation day the CFMEU consisted of three Divisions:
 - i. Construction and General Division;
 - ii. Forestry and Furnishing Products Division (FFPD);
 - iii. Mining and Energy Division.
- 3. From amalgamation day to present, the Construction, Forestry, Maritime, Mining and Energy Union has consisted of four Divisions:
 - Construction and General Division;
 - ii. Manufacturing Division;
 - iii. Maritime Union of Australia Division;

- iv. Mining and Energy Division.
- 4. On amalgamation day the MUA became a Division of the Construction, Forestry, Maritime, Mining and Energy Union. The TCFUA joined the old FFPD Division of the CFMEU and was renamed the Manufacturing Division.
- 5. The Manufacturing Division consists of a number of Districts, including the 'Victorian District' as a continuation of the previous structures in the FFPD.
- 6. On amalgamation day the 'TCF Victorian District' was established in accordance with Manufacturing Division rule 44 (x) 1. (a). The 'TCF Victorian District' is a body distinct from the Victorian District of the Manufacturing Division.
- 7. The **TCF Victorian District** was created for the purpose of facilitating a smooth transition for the former TCFUA officeholders in Victoria to hold office in the newly amalgamated union as outlined in Manufacturing Division rule 44 (v) 6.before transitioning into the new structures of the Victorian District in 2019.
- 8. In accordance with Manufacturing Division rule 44 (x) 1. (d) the **TCF Victorian District** ceased to exist on 1 January 2019.
- 9. The **TCF Victorian District** did not have an account with a bank or any other financial institution nor did it have custody of any real property or monies during the financial year.
- 10. The **TCF Victorian District** had no reason to keep accounting records and did not have any financial affairs during the financial year.
- 11. The **TCF Victorian District** has not traded or carried out financial transactions of any kind and has not expended economic resources or incurred any financial obligations to conduct its activities during the financial year.
- 12. The **TCF Victorian District** did not expend its own economic resources or incur financial obligations so to conduct its activities.
- 13. No person or body corporate or trust expended its own economic resources or incurred financial obligations so that the **TCF Victorian District** could conduct its activities.
- 14. The Manufacturing Division of the Construction, Forestry, Maritime, Mining and Energy Union expended its own economic resources and incurred financial obligations so that the TCF Victorian District could conduct its activities.

15. Notwithstanding the above, the **TCF Victorian District** has functioned in accordance with the rules of the Construction, Forestry, Maritime, Mining and Energy Union including the rules relating to the Manufacturing Division.
