The ROC will examine next year's Annual Return to confirm that the matters giving rise to these concerns are not repeated.

Following receipt of the further declaration, the Annual Return has been filed and no further action is required. Annual Returns are publicly available on the website through the <u>List of Registered</u> <u>Organisations</u>.

The ROC aims to help organisations comply with all the requirements of subsection 233(1) of the RO Act. I make the following comments to assist with future lodgements.

List of Offices

The list of offices was broken down into three main sections – national offices, PSU offices and SPSF offices. The SPSF Group was then further divided into branches, with the offices allocated to each state, such that the branch secretary was in the same part of the AR as the branch representative to Federal Council.

The Federal Secretary and Federal President of the SPSF Group were placed within the CPSU National section of the Annual Return rather than the SPSF Group. These two offices are not properly CPSU National offices, though I note that their ex officio offices of Joint National President and Joint National Secretary were also listed here quite appropriately. This positioning within the

Annual Return made it difficult to identify the Federal Secretary and Federal President as being of the SPSF Group.

It is recommended that the organisation more clearly identify these two offices as belonging to the SPSF Group in future returns.


