Arrangement for conduct of election.

- [1] On 22 January 2020 a decision was issued by a Delegate of the Commissioner in another CPSU-SPSF Group Victorian Branch matter (**E2020/12**) to arrange for an election for offices, including the election of five Federal Council Delegates from the Victorian Branch.
- [2] Subsequently, on 30 March 2020, a decision was issued in this matter (**E2020/73**) to arrange for a collegiate election for the office of Branch Representative to Federal Executive.¹
- [3] As a result of communications from the Australian Electoral Commission (**AEC**), it is apparent that the AEC has, in effect, included the office of Branch Representative to Federal Executive as a stage of the elections conducted in **E2020/12**. As a result, the necessary steps have been taken by the AEC to fill the office that was the subject of the original decision in E2020/73 having done so in conjunction with other elections for the Branch, rather than as a separate election matter.
- [4] I therefore confirm that in those circumstances the AEC is no longer required to conduct election a separate election for Branch Representative to Federal Executive the office that was the subject of election decision E2020/73 as steps already taken by the AEC have already fulfilled that purpose.
