**Re: CPSU, the Community and Public Sector Union – PSU Group, CSIRO Section
Annual Return of Information for Year 2007**

Thank you for your courtesy letter of 31 January 2007, in which you reminded the CSIRO Section of the CPSU of our obligation to lodge an Annual Return of Information for the year 2007, in accordance with subsection 233(1) of the Registration and Accountability of Organisations Schedule (Schedule 1 to the Workplace Relations Act 1996).

I, Pauline Gallagher, Secretary, CSIRO Section of the CPSU hereby declare that:

1. The CSIRO Section is a branch of the PSU Group of the Community and Public Sector Union. The CSIRO Section is divided into eight Sub-Sections (sub-branches).
2. The registered members of the Section and each Sub-Section during the 2006 calendar year have been kept and maintained with this office of the CPSU as required by ss230(1)(a) and 230(2) [s233(1)(a)] of Schedule 1 to the Workplace Relations Act 1996.
3. The names of each Sub-Section (sub-branch) for 2007 are as follows:
 - Australian Capital Territory Sub-Section
 - Northern Australia Sub-Section
 - New South Wales Sub-Section
 - Queensland Sub-Section
 - South Australia Sub-Section
 - Tasmania Sub-Section
 - Victorian Sub-Section
 - Western Australia Sub-Section
4. The Annexure A attached is a list of Section offices and the names, occupations and postal addresses of the persons holding Section offices in 2007.
5. Annexure B attached is the list of Section Councillor offices and the names, occupations and postal addresses of the persons holding offices in 2007. Section Councillors are elected by the membership from their respective Sub-Sections and,

with the Section officers listed in Annexure A, form the Committee of Management for the CSIRO Section.

6. All persons listed in Annexures A and B are employed by the CSIRO except Dr Pauline Gallagher, who is a full-time salaried officer of the Union.
7. The address of the CSIRO Section CPSU in 2007 is 11th floor, 575 Bourke Street, Melbourne VIC 3000.
8. Under the Rules of the CPSU Chapter B, elections must be held in 2007 for casual vacancies to CPSU Governing Council and Section Offices. These are to be held in October-November 2007. There is currently one vacancy in a CPSU Governing Councillor position representing the CSIRO Section. Ms Christiane Ludwig, Section Deputy President, was appointed *pro tem* to the vacancy by the Section Council on 27 October 2006.

Elections will be run by the Section to fill casual vacancies for Sub-Section offices in May-June 2007.

Annual elections will be run by the Section in each workplace to elect workplace delegates in May-June 2007.

9. The Section's number of members on 31 December 2006 was 3215.
10. I provide for your reference (Annexure C) the list of offices elected by the CSIRO Section membership to the CPSU - PSU Group Governing Council and the names, occupations and postal addresses of the persons holding those offices in 2007 (Annexure C). I understand that this information is provided by the CPSU - PSU Group and include it here for completeness.

I hereby certify that the declaration above is a correct statement of information made for the CSIRO Section of the CPSU.

I draw to your attention that the CSIRO Section previously reported all Sub-Section office bearers in the annual return of information. The Sub-Section office-bearers do not have responsibility for Section policy or management of Section funds. I understand from your office that information on Sub-Section offices is not required in this declaration for the CSIRO Section. 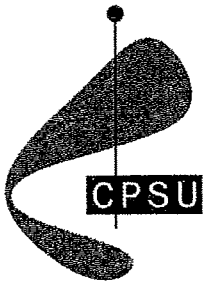
