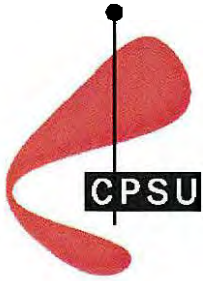
I apologise for our late response as the Regulatory Compliance Branch is experiencing a high workload this year.




