

RE: SECTION 271A – WORKPLACE RELATIONS ACT 1996

Further to our applications for the Financial Years ending 2002 and 2003 for exemption under section 271A of the act I would like to apply for exemption for the Financial Year ending June 2004.

On 19 June 2001 amendments to the CPSU (PSU Group) rules were certified which significantly altered financial management arrangements within the Group.

As a result, all but one of the PSU Groups' "branches" has no funds, property or liabilities under their superintendence, management and control as from 1 July 2001. The exception is CSIRO Section which has an agreement with the PSU Group National Council made under rule 2.3(b)(vi), to continue to manage it's financial affairs.

Accordingly I seek exemption certificates under section 271A of the Act in respect of the 2003/2004 financial year in relation to the following PSU Group bodies:
