DECISION

On 21 January 2003, the PSU Group of the abovenamed organisation lodged in the Industrial Registry the prescribed information in relation to elections for the following offices:

A. National Secretary (salaried position)
 Assistant National Secretary (salaried position)
 National President
 Deputy National Presidents (2)
 Professional Officers Secretary

There was also lodged, at the same time, information in relation to an election for the following positions:

B. Sub-section Officers (see Schedule A)

Section Officers elected by Section Councils from Section Councillors (see Schedule B)

Section Executive Members from each of the following Sections: Community Services (2) Tax (4)

Section 214 of the Workplace Relations Act 1996 and regulation 61 of the Workplace Relations Regulations require an organisation or branch of an organisation registered under the Act, except where an exemption has been granted under section 213, to lodge prescribed information in relation to an election for each office (see definition of 'office' contained in section 4) in the organisation or branch as the case may be.

If a Registrar is then satisfied that an election for an office is required to be held under the rules of the organisation or branch, the Registrar is required by subsection 214(2)(b) to arrange for the conduct of the election by the Australian Electoral Commission.

Accordingly, I am satisfied that an election for the offices specified in paragraph A is required to be held under the rules of the organisation and, under subsection 214(2) of the Workplace Relations Act 1996, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Although the positions specified in paragraph B do not fall within the definition of 'office' under the Act, such positions and their method of election thereto are provided for in the rules of the organisation and, on the basis of an agreement reached with the Australian Electoral Commission, I am also arranging for the conduct by the Australian Electoral Commission of an election for the positions specified in paragraph B.


