Arrangement for conduct of election.

I confirm that the following information is being lodged under the relevant legislation.


I wish to amend the prescribed information regarding vacancies for casual elections contained in the CPSU's application to Fair Work Australia of 9 July 2009.

Please find below responses to the questions and issues raised regarding inaccuracies contained in the CPSU's election request previously sent to FWA on 9 July 2009 and slightly amended on 14 July 2009.

### 3. Other positions listed improperly as vacant or filled:

- 24.03 Community Services Victoria has three positions, all of which are filled. As there are no vacancies, this sub-section has been deleted from the list of vacancies contained in Schedule C as amended and enclosed to this letter.
- 40.05 New South Wales and Australian Capital Territory was wrongly listed as 1 vacancy. Both positions in that electorate are filled. It has been deleted as vacant.






