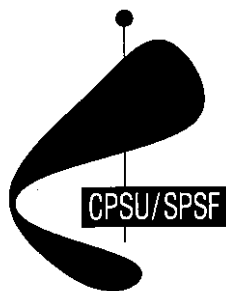
Electronic lodgment

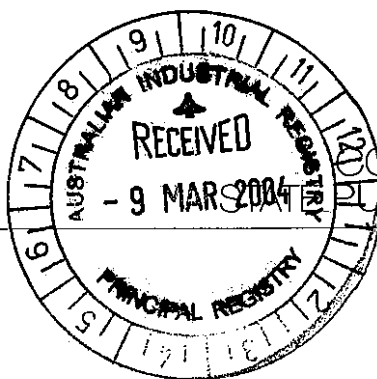



STATEMENT CONCERNING NUMBER OF MEMBERS OF ORGANISATION

The Union's membership on 31st December, 2003 stood at a total of 26,288, of which 5,289 members were unfinancial under the terms of the Organisation's rules.
