STATEMENT CONCERNING NUMBER OF MEMBERS OF ORGANISATION

The Union's membership on 31st December, 2004 stood at a total of 23,075 of whom 20,431 were financial and 2,644 were unfinancial. The number of financial ineligible state members, within the meaning of Section 150 of the RAO Schedule, was 192.
