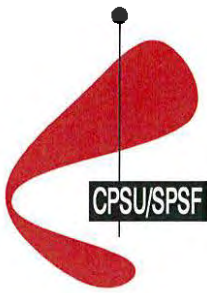
As you may be already aware, on 28 November 2012 the Australian Electoral Commission declared the results of the CPSU's election of its Federal Secretary.

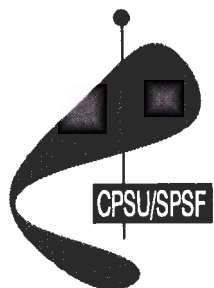
