I acknowledge receipt on 28 February 2014, 17 March 2014, 18 March 2014, 21 March 2014, 24 March 2014, 27 March 2014, 28 March 2014, 31 March 2014 and 1 April 2014 of your Declaration and also Declarations from the various Branch Secretaries providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* for the CPSU and its Branches.

I wish to advise that Section 233 of the Fair Work (Registered Organisations) Act 2009 requires an organisation to lodge a declaration and copies of information with the Fair Work Commission (the Commission) by the 31st March in each year. I note that in 2014 each branch of the CPSU lodged a declaration and the required information. As section 233 places the onus of lodgement on the organisation and not each branch, it is the view of the Commission that the national body of the CPSU is obliged to lodge all of the required information.

From 2015 the Commission intends to create one matter number for the CPSU, instead of a matter number for each branch of the CPSU. The national body of the CPSU will receive a reminder letter at the start of 2015. The branches will not receive a reminder letter.

From 2015 the national body of the CPSU is requested to collate and lodge the information regarding the national body of the CPSU and all of its branches. To assist with this task, I have attached a template annual return.

The documents lodged this year cover most of the required information for the 2014 Annual Return of Information of CPSU, the Community and Public Sector Union-SPSF Group and its Branches with the exception of the CSIRO and WAPOU.

#### **CPSU-SPSF-CSIRO**

I refer to my letter of 17 May 2014 in which I requested information concerning anticipated elections. I look forward to receiving the requested information.

#### **CPSU-SPSF-WAPOU**

I refer to my telephone conversation with Mr Troy Wright in which I requested information in relation to members of the Branch. I note that as at 31 December 2013 the register of members was unable to be kept. I understand that there are now members in the Branch entitled to vote in the upcoming elections.

I requested an email from Mr Wright to confirm the above, and look forward to receiving the requested information.




