



Re: Election for Federal Secretary - CPSU, The Community and Public Sector Union - State Public Services Federation Group.

The last election for the Federal Secretary of the SPSF Group of the Community and Public Sector Union was held and declared by the AEC on 4th July 2000.

Rule 55A of the Union's rules requires that:

"A. The Federal Secretary shall be elected for yearly by secret postal ballot of the whole financial membership of the group...

B. Each election under the rule shall be conducted so that result is declared not earlier than the 1st of June and not later than the 25th of August in an even-numbered year."
