Re: Election for Federal Secretary - CPSU, the Community and Public Sector Union – State Public Services Federation

The last Election for the Federal Secretary of the SPSF Group of the Community and Public Sector Union was conducted and declared by the Australian Electoral Commission on 11 September 2008.

The position is a four year term so that term will expire in 11 September 2012.

Rule 55 A of the unions rules requires that

"A. The Federal Secretary shall be elected four yearly by secret postal ballot of the whole financial membership of the group...

"B. Each election under the rule shall be conducted so that the result was declared not earlier than 1 June and not later than 25 August in an even-numbered year."

Any person can nominate for election as Federal Secretary, however the person must be proposed by at least two members of the Federal Council.

As the term of the current Federal Secretary will therefore expire on 11 September this year 2012, I write to advise Fair Work Australia of this fact and to request arrangements be made with the Australian Electoral Commission to conduct the required election of the position of Federal Secretary. I also write seeking the General Manager to provide under section 189 (2) of The Fair Work (Registered Organisations) Act for a "later day" for the conduct of the election beyond 25 August as prescribed in CPSU SPSF Group Chapter C, Rule 55 B.

The reason for the delay in providing this request was the necessity for the organisation to gather and consider legal advice on the "financiality" of membership and eligibility to participate in elections, by CPSU SPSF members of the Queensland Branch.

This has been necessary, and the subject of some contention, following the amalgamation of our former Queensland Associated Body, the QPSU, with another Queensland State union, AMACSU.

The organisation would suggest that two months' extension would be sufficient, however this would be subject to discussing the availability and capacity of the AEC to conduct a ballot in that time, if it became necessary.

Please request the AEC to contact me regarding the most convenient timing of the election, the provision of a list of those persons (Federal Councillors) eligible to propose a person who is to be nominated.
