The rules of the CPSU require all elections to be conducted under the Proportional Preferential System.

Reasons for election.

Election for offices and positions marked A to D is required as the term of office are due to expire in the normal course of events under the rules of the organisation.

Elected by:

The electorate for the direct voting system for offices marked A is all financial members of the Branch.

The electorate for the direct voting system for offices marked B is all financial members of the relevant electorate (see table below).

The electorate for the collegiate electoral system for offices marked C is members of the Branch Council (totalling a maximum of 19 persons).

The electorate for the collegiate electoral system for offices marked D is the Branch delegates to Federal Council (totalling 4 persons).

Nominations open:

The rules of the Branch require that this election be conducted such that the result is declared not earlier than the 1^{st} of May and not later than the 30^{th} June in each even-numbered year.

The Branch Council has resolved that the elections should be conducted at the earliest opportunity in accordance with the rules.

The election will need to be held in three stages as the electorate for offices marked C is not known until the election of offices marked A & B is declared and the electorate for offices marked D is not known until the election of offices marked C is declared.

In all cases the cut off date for the roll of eligible voters will be 7 days prior to the opening of nominations.

Electorates.

The membership of the Branch is allocated into electorates according to Branch rule 9. For the purposes of the 2004 election, Branch Council have resolved the electorates to be as follows:

The members of the Branch shall be allocated to electorates to be known as Electorate 1, Electorate2, Electorate 3, Electorate 4, Electorate 5, Electorate 6, Electorate 7, Electorate 8, Electorate 9, Electorate 10, Electorate 11 and Electorate 12.

Electorate 1 shall consist of all members employed in or by the University of Tasmania or employed in or by any department or part of a department or by any employer a resolution of the Branch Council declares to be a higher education body.

Electorate 2 shall consist of all members employed in or by the Department of Health and Human Services or hospital, health service, or State authority for which the Minister for Health is the responsible Minister or are employed in or by any department or part of a department or by an employer a resolution of the Branch Council declares to be a health services body.

Electorate 3 shall consist of members employed in or by the Department of Premier and Cabinet, Department of Economic Development, Government House, Parliament House, related State authorities, Ministerial Staff, Unions Tasmania and CPSU employees.

Electorate 4 shall consist of all members employed in or by the Department of Treasury and Finance, Audit office, Printing Authority, the Public Trustee and Retirement Benefits Fund Board or related State authorities.

Electorate 5 shall consist of members employed in or by the Department of Justice and Industrial Relations or related State authorities.

Electorate 6 shall consist of all members employed in or by the Department of Education and or related State authorities.

Electorate 7 shall consist of all members employed in or by the Department of Primary Industries, Water and Environment, the Tasmanian Grain Elevator board, Hobart Water, Esk Water or Cradle Coast Water and related State authorities.

Electorate 8 shall consist of all members employed in or by TAFE Tasmania, the Tasmanian Building and Construction Training Board or related State authorities.

Electorate 9 shall consist of all members employed in or by the Department of Tourism, Parks, Heritage and the Arts, Port Arthur Historic Site management Authority or related State authorities.

Electorate 10 shall consist of all members employed in or by the Department of Infrastructure, Energy and Resources, Pitt and Sherry, Marine and Safety Tasmania,

Private Forests Tasmania or any related State authorities.

Electorate 11 shall consist of all members employed in or by TOTE Tasmania, Civil Construction Corporation, Forestry Tasmania, the Printing Authority or related State authorities.

Electorate 12 shall consist of all members employed in or by the Department of Police and Public Safety, the Tasmanian Fire Service, State Emergency Services, Tasmanian Ambulance Service or related State authorities.

Branch rule 8 provides that one Councillor will represent each electorate on Branch Council for each 300 members or part thereof. Branch rule 9 provides that the minimum size of an electorate is 150 members. Rule 12H of the Federal Chapter C rules provides that electorates are determined from the financial members as at 31st December in the year preceding the election.

The details of financial members of each electorate as at 31 December 2003 and therefore the number of Councillor positions for each electorate is as follows:
