

Hello Lena,

Re: Taxation Subsection election notification

It seems that this is the first notification we have received since the RAO Schedule came into force, for elections of persons to positions which are not offices.

s187 of the RAO schedule requires a request for "non-office positions" to be made direct to the AEC while also forwarding the prescribed information (pursuant to s189) to us at the Registry, along with a copy of the request made to the AEC.

s187 reads:

187 Organisation may ask AEC to conduct elections for positions other than offices

(1) If the rules of an organisation or branch of an organisation require an election to be held for a position other than an office in the organisation or branch, the organisation or branch, as the case may be, may request the AEC to conduct the election.

Note: For the meaning of office, see section 9.

- (2) The request must be:
 - (a) in writing; and
 - (b) signed by an officer of the organisation or branch who is authorised to do so by the committee of management of the organisation or branch; and
 - (c) given to the AEC.
- (3) A copy of the request must also be lodged in the Industrial Registry at the same time as the prescribed information in relation to the election is lodged (see section 189).

You will see that under s189(3)(c), that the making of a request to the AEC under s187 is a requirement which must be met before a Registrar arranges an election for "non-office positions".

s189 reads:

189 Registrar to arrange for conduct of elections

- (1) An organisation or branch of an organisation must lodge in the Industrial Registry the prescribed information in relation to an election that is to be conducted by the AEC.
- (2) The prescribed information must be lodged before the prescribed day or such later day as a Registrar allows.

Note: This subsection is a civil penalty provision (see section 305).

(3) If:

- (a) the prescribed information is lodged in the Industrial Registry by the organisation or branch (whether or not before the prescribed day or the later day allowed by a Registrar); and
- (b) a Registrar is satisfied that an election is required to be held under the rules of the organisation or branch; and
- (c) if the election is not an election for an office-the organisation or branch has made a request under section 187;

a Registrar must arrange for the conduct of the election by the AEC.

Could you please arrange to forward a copy of a request made to the AEC for the conduct of the election so that we can process the matter.

If CPSU believes that the positions are in fact "offices" under the Act, then we would need to receive a submission on why the Union believes that to be the case. On looking at our records, (pre RAO schedule), it does not appear that there has been any issue about this in the past, it is just that the RAO schedule makes special provision for election for non-office positions, whereas previously such elections were done under an informal arrangement with the AEC, and only where they were done in conjunction with elections for offices.
