Dear Registrar,

During the Tax sub-section elections in 2005, the Returning Officer from the Australian Electoral Commission identified a gap in the CPSU (PSU Group) rules, pertaining to the term of office of Tax sub-section officers. As required by law we responded to the post-election report and I have attached that letter for your information.

It would appear that, by omission, the term of office for said positions was never specified in the rules, and that the term has instead been governed by custom and practice. The elections have taken place on an annual basis for quite some years, but it would seem as if they have not until recently been conducted by the AEC. The move to the AEC would have come about in conjunction with a significant restructure of the CPSU and the introduction of Divisions. This restructure saw the introduction of the provisions governing the Tax subsection elections into the CPSU (PSU Group Rules).

As stated in the abovementioned response to the post election report, it is the intention of the CPSU to seek alterations to the Rules that specify this term of office. The reason why this was not done in 2005 is that the National Elections were being conducted and changes to the Election Rules were deemed inappropriate.

The post election report from the National Elections has also identified areas that need clarification and we will endeavor to have all of these changes made later in the year.

#### Re: Post Election Report (CPSU E2005-27) - Rules difficult to interpret

In the post election report for the recent elections for the Tax sub-section positions the AEC identified that the rules of the CPSU-PSU Group do not appear to specify the term of office for Tax sub-section officers.

This response is submitted under section 197 of Schedule 1B of the WR Act (1996).

We agree with the AEC that the term of office for Tax sub-section officers does not seem to be specified anywhere in our rules.

It would seem as if custom and practice has established the term to be 1 year and the gap in our rules has not previously been noticed.

As we are now aware of this issue relating to the CPSU-PSU Group rules, we shall initiate the process to have the rules altered to clearly set out the term of office for Tax sub-section officers.

#### **DECISION**

[1] On 23 January 2006 the PSU Group of the abovenamed organisation lodged in the Industrial Registry prescribed information in relation to an election for the following **non-office positions:**

Sub-section Secretaries (Schedule A)
Sub-section Presidents (Schedule B)
Assistant Sub-section Secretaries (Schedule C)

[2] Following an examination of the rules of the organisation, comment was sought from the organisation regarding the apparent lack of specification in the rules of a term of office for the above positions. A response to that request was received by email on 10 February 2006, which conceded the absence of a term of office in the rules, and indicated that "by custom and practice"…"elections have taken place on an annual basis for quite some years".

I note that the lack of specification regarding the term of office in the rules was also made in the post election report dated 2 June 2005 signed by the Australian Electoral Commission Returning Officer Jeff Howarth following last year's election E2005/27.

In the absence of a term of office being specified in the rules, I am unable to be "satisfied that an election is required to be held under the rules of the organisation or branch", in accordance with paragraph 189(3)(b) of Schedule 1B of the Act.
