I have noted that the annual returns of the above organisation for 2003 have not yet been lodged.

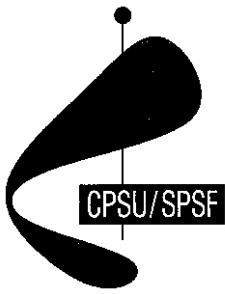
