Schedule 1B - Registration and Accountability of Organisations

<u>STATEMENT</u>

As prescribed in Schedule 1B – Registration and Accountability of Organisations, Part 2 – Records to be kept and lodged by organisations, Section 230 Records to be kept and lodged by organisations, Sub-Section 230(1)(a) and (2) as follows:

- (1) An organisation must lodge in the Industrial Registry once in each year, at such time as is prescribed:
