Dear Ms Walkington and Ms Mays

RE: Annual Return AR2010/2515

I refer to my conversation with Ms Mays on 5 May 2010. In that conversation I informed Ms Mays that the annual return will be posted on the Fair Work Australia website once it is filed and that there appear to be personal addresses in the annual return. Ms Mays and another colleague with her indicated that some of the employees work in sensitive areas and therefore they do not want personal addresses to appear on the website. I told Ms Mays that the annual return can be resubmitted with the address of the office holders care of the physical address of the Organisation's office in Perth.

In addition, I informed Ms Mays that under section 233(1)(b) of the *Fair Work Registered Organisations Act 2009* ('RO Act') a declaration needs to be provided by the Secretary or other prescribed officer that the information kept under sections 230(1)(b)(c) and (d) is "a correct statement of the information contained in those records". I confirmed with Ms Mays that the information in relation to sections 230(1)(b) and (c) were contained in the second paragraph of the cover letter of the annual return, but were not in the form required by the RO Act.

We are still awaiting an amended annual return AR2010/2515. Please note the annual return has to be re-lodged in its entirety.
