Fair Work (Registered Organisations) Act 2009

Chapter 8 – Records and Accounts

Declaration s233(1)(a)

As prescribed in Fair Work (Registered Organisations) Act 2009, chapter 8 – Records and accounts, Part 2 - Records to be kept and lodged by organisations, Section 230 Records to be kept and lodged by organisations, Sub-Section 230(1)(a) and (2) as follows:

230(1)(a) *An organisation must keep the following records:*

- (a) *a register of its members, showing the name and postal address of each member and showing whether the member became a member under an agreement entered into under the rules made under subsection 151(1);*

230(2) *An organisation must:*

- (a) *enter in the register of its members the name and postal address of each person who becomes a member, within 28 days after the person becomes a member;*
- (b) *remove from the register the name and postal address of each person who ceases to be a member under the rules of the organisation, within 28 days after the person ceases to be a member; and*
- (c) *enter in that register any change in the particulars shown on the register, within 28 days after the matters necessitating the change become known to the organisation.*

I, **Toni Beverley Walkington**, am the authorised officer of the **Community and Public Sector Union SPSF Group, Western Australian Branch**, state that the register of members during the immediately preceding calendar year, being **31 December 2010**, has been kept and maintained as required by ss230(1)(a) and (2).

Declaration s230(1)

As prescribed in Fair Work (Registered Organisations) Act 2009, chapter 8 – Records and accounts, Part 2 - Records to be kept and lodged by organisations, Section 230 Records to be kept and lodged by organisations, Section 230(1)(b) (c) (d) and Regulation 147(d)

230(1) *An organisation must keep the following records:*

- (b) a list of the offices in the organisation and each branch of the organisation;*
- (c) a list of the names, postal addresses and occupations of the persons holding the offices;*
- (d) such other records prescribed.*

For paragraph 230(1)(d) of the Fair Work (Registered Organisations) Act 2009 and Reg 147 (d), the following records are prescribed in relation to an organisation:

- (a) a record of the name of each branch of the organisation;*
- (b) a record of the name of each branch that commenced operation in the previous 12 months;*
- (c) a records of the name of each branch that ceased operation in the previous 12 months;*
- (d) a record of the address of
 - (i) the office of the organisation; and*
 - (ii) the office of each branch of the organisation;**
- (e) a record of each election that must, under the rules of the organisation, be held during each year commencing 1 January:
 - (i) for an office of the organisation; and*
 - (ii) for an office in a branch of the organisation.**
- (f) for a record of the number of members on 31 December in the previous year;*
- (g) if the organisation has entered into an agreement mentioned in subsection 151(1) of the Act – a record of the number of members of the organisation who were, on 31 December in the previous year, ineligible State members, in relation to the organisation, within the meaning of section 150 of the Act.*
