#### Re: Post Election Report for CPSU, SPSF Group WA Branch [E2016/70]

Thank you for the post-election report pursuant to s 197(1) of the Fair Work (Registered Organisations) Act 2009 "the Act", received on 17 October 2016. The Branch acknowledges the commentary, recommendations and statements in relation to rules of the Organisation and / or Branch that were difficult to interpret or apply during the election. In accordance with s198(2) of the Act, the Branch advises of the actions it intends to take regarding the relevant rules:

#### Roll of voters

#### AEC recommendation

"It is recommended that CPSU- SPSF Chapter C Group Rule 17.2 (e) be amended to comply with s143(3) of the Act"

#### WA Branch proposed action

This matter has been raised in a number of the post-election reports from the various returning officers in the recent round of CPSU-SPSF Branch elections. We understand that the process of drafting the changes you have raised are currently being prepared by the CPSU(SPSF) Federal Office

#### AEC recommendation

"Rule 10 (Groups) of the CPSU; Chapter A- (General Rule) be amended by inserting in rule 10 (c) the following:

(iiA) any officer or employee of the Union performing duties in the SPSF Group."

#### WA Branch proposed action

Refer matter to CPSU- SPSF Group Federal Council and Executive and the National Officers Committee (Joint SPSF and PSU body) given such an action must be considered and authorised by these bodies. Under the rules of the CPSU, the WA Branch does not have the unilateral power to progress the recommendation.

#### **Candidate statements**

#### **AEC** statement

WA Branch Rule 33.2 becomes redundant due to the application of WA Branch Rules 1 and 33.1 and CPSU- SPSF Chapter C Group Rule 28.

#### WA Branch proposed action

The WA Branch accepts the advice. The WA Branch will make application to the Fair Work Commission to delete WA Branch Rule 33.2.

#### **Multiple Nominations**

#### AEC recommendation

"It is recommended that CPSU- SPSF Chapter C Group Rule 28 be amended to include Proxy Councillors"

#### WA Branch proposed action

In effect, the AEC is advising that Chapter C should be amended to preclude a candidate nominating for the Councillor and Proxy Councillor offices. WA Branch Rule 9.3 confirms a person cannot hold both offices. The WA Branch will refer matter to CPSU- SPSF Group Federal Council and Executive given such an action must be considered and authorised by these bodies. Under the rules of the CPSU, the WA Branch does not have the unilateral power to progress the recommendation.

#### Absent voting

#### AEC recommendation

"It is recommended that CPSU – SPSF Chapter C Group Rule 37.3 (c) be amended from 10 days to 15 business days"

#### WA Branch proposed action

Refer matter to CPSU- SPSF Group Federal Council and Executive given such an action must be considered and authorised by these bodies. Under the rules of the CPSU, the WA Branch does not have the unilateral power to progress the recommendation.

#### **WA Branch Rules**

#### **AEC** statement

WA Branch Rule 33.7 references Rule 54B of CPSU – SPSF Chapter C Group Rules in relation to the conduct of an election. Given subsequent amendments to Chapter C that reference is now inaccurate.

#### WA Branch proposed action

The WA Branch accepts the advice. The WA Branch will make application to the Fair Work Commission to amend the WA Branch Rules to reference the correct rule in Chapter C.

## Organisation must respond to the post-election report of the Australian Electoral Commission: E2016/70

On 17 October 2016 the Fair Work Commission (the Commission) received a post-election report from the Australian Electoral Commission (AEC) for election E2016/70 dated 17 October 2016. The AEC will have also provided the report to the organisation under section 197 of the Fair Work (Registered Organisations) Act 2009 (the RO Act).

The report identifies rules that were difficult to interpret or apply, in particular rules CPSU-SPSF Chapter C Group Rules 17.2 (e), 25.1 (c), CPSU Chapter A – General Rule 10 (*Groups*), WA Branch Rule 1, WA Branch Rule 33.1, WA Branch Rule 33.2, CPSU-SPSF Chapter C Group Rule 28, WA Branch Rule 9.3, CPSU-SPSF Chapter C Group Rule 28, 37.3 (c), WA Branch Rule 33.7. This letter serves as a reminder of the obligations imposed on the organisation or branch as a consequence of the AEC's report. If a response has already been sent to the AEC and made available to all members please disregard this letter.

#### A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regs 141(4) and (5)).

#### A written response must be provided to the AEC

A written response must be provided to the AEC within 30 days of receipt of the report. The organisation's response must include whether the organisation or branch intends to take action and if so what action the organisation or branch intends to take (s198(2)).

#### Extract of report must be made available to members

The organisation or branch must make the section of the report relating to the difficult rules available to its members (s198(3)). This extract from the report must be made available to the members before or at the same time as the organisation's response is made available to members.

#### Written response must be made available to members

A copy of the organisation's response to the AEC must be made available to members either:

within 30 days after the response is given to the AEC, or

published in the next edition of the organisation or branch journal (s198(5))

Subsection 198(6) and regulation 142 prescribe ways in which the relevant extract and the copy of the response can be made available to members. These do not limit the ways in which they can be made available to members. The organisation will comply if it does all of the following:-

- publish the report extract and the copy of the response in the next edition of the organisation or branch's journal; and
- within 30 days of giving the response to the AEC:
  - lodges with the Commission a copy of the relevant extract and response, together with a declaration that a copy will be provided to any member who so requests; and
  - give notice in the next edition of the organisation or branch's journal, or an appropriate newspaper, that a copy of the relevant extract and response are available on request to each member free of charge; and
- publish the relevant extract on the website within 14 days after receiving the report, and publish the response on the website within 14 days of giving the response to the AEC (reg 142(2)).

#### Penalties may apply

If the organisation or branch does not:

- respond to the AEC within 30 days,
- make the extract of the report relating to the rules available to members no later than the organisation's response is made available to members, or
- make the organisation's response available to members within 30 days or in the next edition of the journal,

the organisation may face penalties under the RO Act. Each requirement listed above is a civil penalty provision that may result in fines for the organisation

As noted above, if the response and report have already been made available to members and the AEC, please disregard this letter. If you have any questions in relation to these obligations please contact the Commission for assistance by email to orgs@fwc.gov.au.

#### If the organisation or branch decides to alter its rules in response to the AEC's report

If the organisation or branch decides to alter its rules in response to the AEC's report, the Regulatory Compliance Branch of the Commission is able to provide advice and assistance regarding draft alterations, as well as about the processes required to make the alterations. Section 143(3) of the Fair Work (Registered Organisations) Act 2009 states:

The day provided for in the rules of an organisation as the day on which the roll of voters is to be closed (see paragraph (1)(e)) must be a day no earlier than 30 days, and no later than 7 days, before the day on which nominations for the election open.

It is recommended that CPSU-SPSF Chapter C Group Rule 17.2 (e) be amended to comply with Section 143(3) of the Fair Work (Registered Organisations) Act 2009.

• The returning officer was unable to ascertain the standing as a member of the Community and Public Sector Union SPSF Group, Western Australian Branch, of persons employed by the Branch who were included in the roll of voters provided by the Branch because the application of the rules depended on evidence not available to the returning officer. This problem in the organisation's rules was recently considered by the Federal Court in Lillywhite, in the matter of an application for an inquiry in relation to elections for offices in the CPSU, Community and Public Sector Union, SPSF Group Victorian Branch [2016] FCA 700.

The returning officer notes that the organisations rules in respect of the PSU Group allow employees of the organisation to be members of the CPSU and allocates them to the PSU Group: see rules 2 (Part 1)(A.1)(ii) and 10(b)(ii) of the CPSU, the Community and Public Sector Union; Chapter A - General Rules, subject to a possible allocation to the SPSF Group by the National Officers Committee ('NOC') under rule 10(c)(iii).

It is recommended that CPSU, the Community and Public Sector Union; Chapter A - General Rules should be amended as follows:

Rule 10 (*Groups*) of the CPSU, the Community and Public Sector Union; Chapter A - General Rule) be amended by inserting in rule 10(c) the following:

(iiA) any officer or employee of the Union performing duties in the SPSF Group;

#### **Candidate Statements**

• WA Branch Rule 1 states:

These rules are in addition to the federal rules of CPSU, the Community and Public Sector Union and shall apply to the Western Australian Branch so far as they are not in conflict with the federal rules.

WA Branch Rule 33.1 states in part:

Every election required by these rules shall be conducted in accordance with Chapter C the Federal Rules.

- WA Branch Rule 33.2 states:
   Branch policy may provide for candidates' information of a prescribed form to accompany ballot papers issued in the conduct of a Branch election.
- CPSU-SPSF Chapter C Group Rule 28 Provides for Candidate States.

WA Branch Rule 33.2 becomes redundant due to the

application of WA Branch Rules 1 and 33.1 and CPSU-SPSF Chapter C Group Rule 28.

#### **Multiple Nominations**

WA Branch Rule 9.3 states:

Proxy Branch Councillors shall perform the duties and exercise the powers of Councillors during the Councillors' absence, unavailability or when a position of Councillor is vacant. Should there be more than one position of Proxy Branch Councillor within an Electorate, the allocation of proxies shall be by rotation.

CPSU-SPSF Chapter C Group Rule 28 covers Multiple Nomination but make no provision regarding nominations received simultaneously for Proxy Branch Councillor and Branch Councillor.

WA Branch Rule 9.3 makes it clear that a person cannot hold both the office of Branch Councillor and Proxy Branch Councillor.

It is recommended that CPSU-SPSF Chapter C Group Rule 28 be amended to include Proxy Branch Councillor.

#### **Absent Voting**

CPSU-SPSF Chapter C Group Rule 37.3 (c) states in part:

To provide the absent voters with a reasonable opportunity to return the ballot the returning officer shall not count the ballot until ten days from the date of posting of the ballot paper/s.

The Australia Post website indicates standard delivery for domestic letters is 2 to 6 business day. 10 days is insufficient time to ensure an eligible voter could receive, consider and return their ballot material before the close of the ballot.

It is recommended CPSU-SPSF Chapter C Group Rule 37.3 (c) be amended from 10 days to 15 business days.

#### **WA Branch Rules**

WA Branch Rule 33.7 states in part:

The persons eligible to accept nomination shall be the members of the Branch Council and the election shall be conducted in accordance with Rule 54B of Chapter C of the Federal Rules, with the necessary changes being made.

CPSU-SPSF Chapter C Group Rules have been updated. Rule 54B now refers to membership and not the conduct of an election.
