

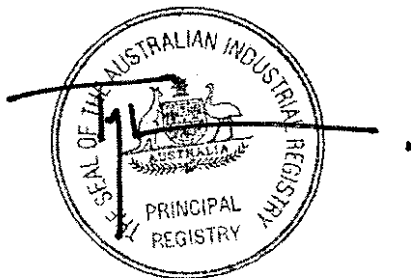
Arrangement for conduct of election.

Re: Arrangement for the conduct of an election in accordance with section 189 of Schedule 1B of the Workplace Relations Act 1996 - E2005/50

A copy of the Registrar's decision in relation to the above matter is enclosed.

Any queries concerning the conduct of the subject election should be directed in the first instance to the Australian Electoral Commission, New South Wales on (02) 9375 6360.

I draw your attention to the following matters concerning the prescribed information lodged in relation to the election:

- Section 214 of the Workplace Relations Act 1996 has been repealed. The information previously required pursuant to that section is now required to be lodged under subsection 189(1) of the RAO Schedule in accordance with the requirements of regulation 138 of the RAO Regulations.
- Under subregulation 138(1)(f) an organisation is required to include in the prescribed information details of "the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed." Could you please ensure that such information is included in any future election notifications lodged in the Industrial Registry. In the case of your Association, the relevant rule for this purpose is subrule 23(f)(ii).
- The reference to "Five (5) Ordinary Members" should have been to "five Executive Councillors" consistent with the wording contained in the rules of the Association. I refer you in this matter to rule alterations certified under R2003/290 and R2004/381.
