


- (a) The name of the office in respect of which an election is required is National Assistant Secretary – Commonwealth Bank Officers' Section.

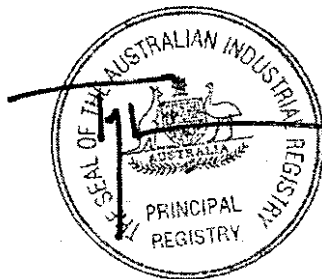
