Further to our letters of 23 April 2001, 29 June 2001 and various discussions, a legal opinion has been obtained clarifying my ability to occupy the positions of National Vice President (FSU), President (CBOS) and Branch Secretary (CBOS) Queensland Branch which also represents the Branch as National Executive Delegate. This now allows us to proceed with the remaining elections. Consequently, the Branch Committee of Management have now passed the following motion:

**"That the Secretary request the Industrial Registrar to conduct elections for the positions of Branch President (1), Branch Committee members (13) and a subsequent collegiate ballot for the positions of Branch Vice-Presidents (2), National Conference Delegate (1) and Deputy National Executive Delegate (1).**

**Further that only FSU members are eligible to stand for any position. The notice of election to be advertised by way of public notice in *The Courier Mail*. Such election to be held on a first past the post system of voting."**

Accordingly, I declare that I am authorised to lodge the following information, being prescribed information, in relation to an election in the Commonwealth Bank Officers' Section, Queensland Branch of the Finance Sector Union of Australia and am also authorised to sign this statement which is lodged in accordance with sub-section 214(1) of the Workplace Relations Act 1996.



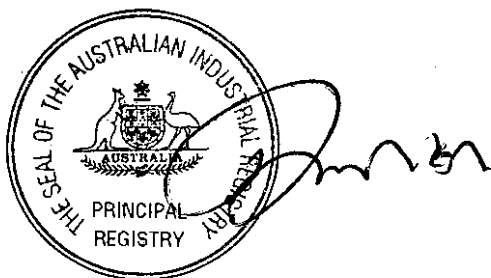

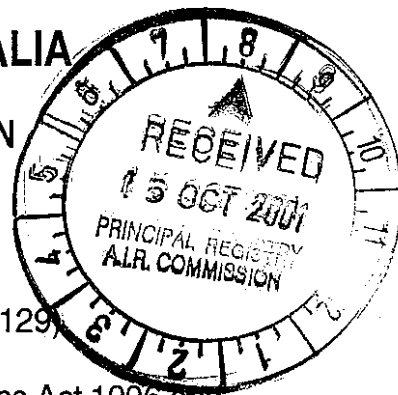
