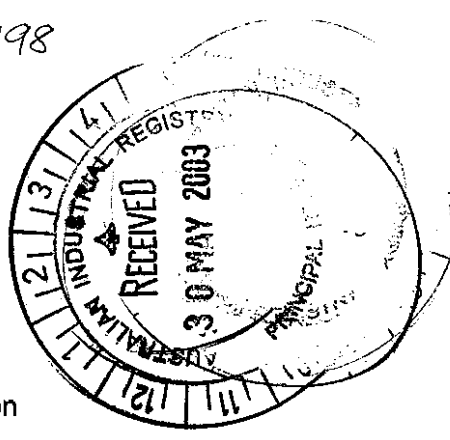

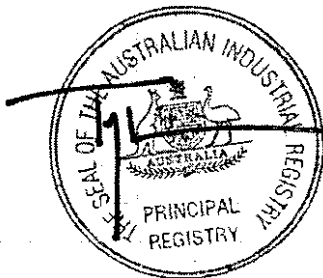
DECISION
