- Section 214 of the Workplace Relations Act 1996 has been repealed. The information
 previously required pursuant to that section is now required to be lodged under
 subsection 189(1) of the RAO Schedule in accordance with the requirements of
 regulation 138 of the RAO Regulations.
- Under subregulation 138(1)(f) an organisation is required to include in the prescribed information details of "the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed." Could you please ensure that such information is included in any future election notifications lodged in the Industrial Registry. In the case of the abovenamed branch, the relevant rule for this purpose is subrule 43.3.5A.
