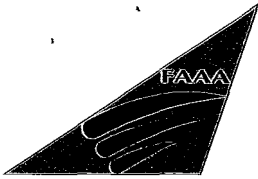

In all cases shall be called 15 October 2007.


Nominations Close:
