The FAAA National Entity responsibilities including any financial or other requirements have been split equally between the FAAA International and the FAAA Domestic Regional Divisions, this was reported at the end of the financial period 30 June 2008.

The National Entity account had ceased to operate and indeed a request for exemption for reporting units was requested and granted for the financial years ending 30 June 2009, 30 June 2010, 30 June 2011 and 30 June 2012.

Therefore, under this same section s271(1) of the Fair Work (Registered Organisations) Act 2009 we are applying for further exemption of any reporting requirements for the National Entity from the end of year period June 2013.
