If you decide to lodge electronically you have these choices:

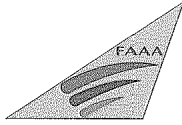
- register as a user and then lodge your documents via the AIR eLodgment page of the AIRC website.


