### **Flight Attendants Association of Australia Outstanding 2003 Annual Return of Information**

The purpose of this letter is to remind you of the requirement of organisations to lodge annual returns of office holders etc within the first three months of each calendar year.

There is no record of such annual return for the International Division of the Flight Attendants Association of Australia.

Accordingly, would you please advise, by declaration the following information:

- (a) that the register of members of the International Division, showing the name and postal address of each member (and showing whether the member became a member under an agreement entered into under rules made under subsection 151(1)) has been kept and maintained in respect of 12 month period ending 31 December 2002; and
- (b) the formal name of the Division of the organisation (and for any of its branches) and the respective postal and physical addresses [as at the date of the declaration].
- (c) a list of the names, postal addresses and occupations of the persons holding office of the International Division of the organisation (and of each of its branches, if any) [as at the date of the declaration].
- (d) a record of any election due to be held in the International Division (and of each of its branches, if any) during the calendar year 2003. [as at the date of the declaration].

You would be aware that the legislation covering the regulation of registered organisations was changed in a number of respects on 12 May 2003, including changes to the requirements of organisations and branches or divisions to lodge prescribed information. What I have set out above should satisfy the requirements for the International Division under the former legislation.

We will advise the Association and its Divisions at a later stage of the changed requirements to operate in respect of the annual returns to be lodged in 2004.




