Further to my phone conversation with you about impending elections that need to be organised I attach the following information.

Statement and Notice of prescribed information under s.189(1) of the RAO Schedule and RAO Regulation 138.

PRESCRIBED INFORMATION IN RESPECT OF ELECTIONS

An election is required for the following offices of the International Division of the Association as follows:

Divisional Secretary (1) Divisional Assistant Secretary (1) Divisional President (1) Divisional Vice President (1)

International Division Councillors as follows:

Sydney Long Haul base (5) Melbourne Long Haul Base (1) Brisbane Long Haul Base (1)

Please note that Rule 8(b) also makes mention of Perth Long Haul Base (1) and Australian Airlines (1). These two positions are redundant because the Perth Base and Australian Airlines no longer exist. We will need to make further Rule changes in the near future to reflect this fact.

The reason for this election is that Rule 36(4) of the Association Rules require an election to take place every 4 years. Nominations are required to be opened from 15 February 2008 and remain open for 28 days and the election needs to be completed by 30 June 2008. The roll of voters is to be closed 7 days prior to the opening of nominations.

The financial members of the International Division are eligible to vote for the above positions as per Rule 32 (6).

The voting system is direct. By virtue of holding the above offices, each elected officer is also a member of Federal Council.
