[1]	On 21 August 2013 Hair and Beauty Australia lodged with the Fair Work Commi	ssion
the p	rescribed information in relation to an election for the following offices:	

President	(1)
Vice-President	(1)
Secretary	(1)
Treasurer	(1)
Ordinary Committee Members	(6)

- [2] On 28 August 2013, the organisation lodged an application for an extension of time to allow a later day for lodgement of the prescribed information. The prescribed day is the day occurring 2 months before the first day when a person may, under the rules of the organisation, become a candidate in an election. The rules provide that the nominations will open on the first Monday in October in the year elections are due to be held.
- [3] The organisation has explained that the late lodgement of the prescribed information was due to inadvertent omission of some administrative processes in the absence of a dedicated person to oversee administrative duties following executive personnel changes. I allow a later day up to the date of actual lodgement, namely 21 August 2013 and grant the extension requested.
- [4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Hi Malynda

I tried to call today you but was advised you were not available.

I have had a chance to look at the prescribed information you sent last Thursday concerning an election within HABA.

In the prescribed information it states that nominations will open on the fourth Tuesday in February 2011 (I think this should be 2013) or as advised by the AEC.

However, rule 38(d) of the rules of Hair and Beauty Australia state that nominations for elections will open on the first Monday of October.

I just wanted to ask you the reason why you have lodged the prescribed information now and why you want the election so soon. I think that you are just following the previous election in providing that the nominations will open on the fourth Tuesday in February.

The problem is that my superiors are unlikely to arrange for the conduct of the election so soon when the rules of Hair and Beauty Australia provide that nominations will not open until October.

My view is that you don't need to lodge the prescribed information until later this year.

Based on the rules of Hair and Beauty Australia, the nominations should open on 7 October 2013. You need to lodge the prescribed information **2** months before this date (that is before 7 August 2013).

I know this is probably confusing so could you please call me when you are available.
