#### Declaration and information lodged under subsection 233(1) for 2019 (AR2019/84)

I acknowledge receipt by the Registered Organisations Commission (**the ROC**) on 27 June 2019 of your organisation's further amended Annual Return (**Further Amended Annual Return**) which provides information under subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (**the RO Act**).

On 10 April 2019, a notification of change was lodged with the ROC to notify us of changes to your organisation's records with respect to its list of officers as contained in the Annual Return for 2018 (**the NoC**). However the changes contained in the NoC was not reflected in the Annual Return for 2019 initially lodged on 12 February 2019 nor in the amended Annual Return subsequently lodged on 10 April 2019. As a result, this Further Amended Annual Return was lodged to reflect the changes in the NoC. Thank you for providing your Annual Return.

The documents lodged provide most of the required information for the 2019 Annual Return of the Health Services Association of New South Wales.

The ROC aims to help organisations comply with all the requirements of subsection 233(1) of the RO Act. To assist you with your future lodgements, I note that your organisation has an obligation to, amongst other things, keep records of its officers under the RO Act and this includes continually maintaining its register so as to ensure that it is up to date at all times. The ROC will examine next year's Annual Return to confirm that the matters giving rise to these concerns are not repeated.
