- send an email with the documents you wish to lodge attached to: riateam2@air.gov.au

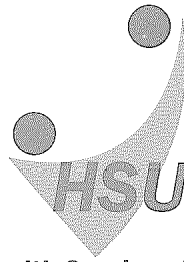
