

*Alteration of other rules of organisation.*

**DECISION**

[1] On 15 January 2008 the Health Services Union lodged in the Industrial Registry a notice and declaration setting out particulars of alterations to the Rules of the organisation.

[2] The particulars set out the following alterations to the Rules of the organisation:

- Insert new Rule 28(d)(iii),
- Amend Rule 48, and
- Insert new Rule 48H

[3] The alterations seek to amalgamate the organisation's Victoria No. 1 and Victoria No. 5 Branches on 1 February 2008 and abolish the Victoria No. 5 Branch on the same day.

[4] On 25 and 31 January 2008 the organisation lodged declarations and other material in the Registry that indicated that:

- the Victoria No. 1 and Victoria No. 5 Branches had both consented under the rules of the organisation to the amalgamation, and
- the officers of the Victoria No. 5 Branch had either resigned or understood and accepted that their offices are to be abolished and their terms of office are thereby to be truncated.

[5] On the information contained in the notice I am satisfied the alterations were made in accordance with the rules of the organisation.

[6] With the consent of the organisation I have corrected under s.159(2) the following typographical, clerical or formal error in the alterations:

- Part 6 of Rule 48H – delete the comma immediately after the first reference to *the Victoria No. 1 Branch* and replace it with a full stop.

[7] In my opinion, the alterations comply with and are not contrary to the Workplace Relations Act, Schedule 1 thereof, awards and collective agreements, are not otherwise contrary to law, and I certify accordingly under subsection 159(1) of Schedule 1 of the Act.
