***Reasons for election:***

The election for the aforementioned positions is required under rule 29 of the rules of the HSUA. The term of the current officers expires in October thus requiring elections to be held.

***Elected by:***

Collegiate vote of the National Council at the biennial meeting of the National council under HSUA Rules 29 and 41.

***Nominations open:***

Nominations for the positions of National President, National Vice President, National Secretary, Senior National Assistant Secretary, National Assistant Secretary and National Trustees (2) will open in accordance with rule 29 of the HSUA. Under Rule 29 of the HSUA the date for the opening of nominations is the 1<sup>st</sup> of September 2004.

***Nominations close:***

In accordance with rule 29(e)(i) the closing date for nominations is the last Friday of September 2004 that date being the 24<sup>th</sup> of September 2004.

***Cut off date for roll:***

As this is a collegiate vote of the HSUA National Council the role of voters is limited to members of National Council. Under rule 41(a) voting shall be by show of hands or by such other method as the meeting may decide.

***Election date:***

The HSUA requests the registrar grant election for the positions of national officers of the HSUA be held on the 13<sup>th</sup> of October at 11.30.
