In the commentary on the FWA website in relation to the Health Services Union the webpage lists Branch sites as including:

Change of information of Branch details

I am writing to you in your capacity as the General Secretary of the newly formed HSU East Branch of the Health Services Union.

On 24 May 2010, alterations to the rules of the organisation were certified by Fair Work Australia (FWA). I refer in particular to the alterations providing for the merger of the Victoria No.1 and Victoria No. 3 Branches with the New South Wales Branch to form the HSU East Branch.

Under section 233(2) of the *Fair Work (Registered Organisations) Act 2009* (the Act), an organisation or a branch of an organisation must, within 35 days, lodge with FWA notification of any change made to the records required to be kept under subsection 230(1)(b),(c) and (d) of the Act. Briefly, these subsections relate to the list of offices, the names of the persons holding those offices and to, among other things, the address details of the organisation or branch.

I am aware that under your rules a transitional period is currently in operation. This period operates until the declaration of the election for offices within the Branch. My concern at this time relates only to the address and communication details of the HSU East Branch.

As there is a mandatory obligation on organisations and branches to supply this information, you are requested to lodge the information under cover of a declaration by 14 July 2010. As I mentioned, at this time I only require complete address and communication details of the HSU East Branch. Particular interest is with the operational locations of the Branch, that is; whether more than one address location should be recorded for the branch and, if so, your instructions concerning contact arrangements with those locations.

I further request, once the election for offices is declared, lodgement of that information under cover of a declaration made by you. In that declaration, rather than provide the private address details of the individual officers you may instead provide the Branch's office address.

Re: Failure to lodge under s.233(2) *Fair Work (Registered Organisations) Act 2009*

As outlined in correspondence to Mr Williamson from Robert Pfeiffer of this office dated 1 July 2010, it is a requirement of the *Fair Work (Registered Organisations) Act 2009* that notification of changes to certain details of registered organisations and branches be lodged with Fair Work Australia, under declaration, within 35 days of the changes [ss.233(2), 230(1)(b) & (d) and sub-regulations 147(a) to (e) of the *Fair Work (Registered Organisations) Regulations 2009* refer].

No such notification has been lodged in respect of the abolition of the Victoria No.1, Victoria No. 3 and New South Wales Branches, and creation of the HSU East Branch arising from alterations to rules on 24 May 2010.

In addition to the failure of the HSU to meet the mandatory requirement to lodge this information, day to day practical difficulties arise from the fact that FWA has received no information as to the registered address of the branch, or communication details to be used for officers of the branch in relation to the business of the branch.

Since 24 May 2010, a number of applications for right of entry permits have been received under the name of abolished branches. Further, nothing has been received from the organisation indicating to whom correspondence and permits for East Branch officials should be forwarded, or at what address or addresses.

Until such time as a full declaration and notification under s.233(2) has been lodged with FWA, relating to all the relevant changes arising from the abolition of the Victoria No.1, Victoria No. 3 and New South Wales Branches and creation of the HSU East Branch, no further permit applications made under the names East Branch, Victoria No.1 Branch, Victoria No. 3 Branch or New South Wales Branch will be processed.

The declaration and notification may be forwarded by email to orgs@fwa.gov.au, provided the declaration contains a scanned signature of the declarant.
