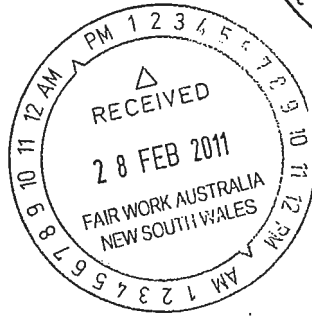

Union Council recently received the resignations of Jamie Martorana, Assistant Divisional Secretary and Eileen McEvoy, General Representative from New South Wales.


