Comments to assist with future Annual Returns

I note that regulation 149 of the *Fair Work (Registered Organisations) Regulations 2009* requires that Annual Returns be lodged by 31 March each year. Please ensure in future that this requirement is met.

The reference to legislation in paragraph 4 of the Declaration should refer to subsections 230(1)(a) and (2) and 233(2)(a) of the *Fair Work (Registered Organisations) Act 2009* rather than schedule 1B of the *Fair Work Act 2009*.

Finally, I note that following the decision of *re Health Services Union of Australia* (D2006/54), the 'Health Services Union of Australia' was renamed as the 'Health Services Union'. The Annual Return should contain a precise declaration of the Branch's name.
