In paragraph 4 of your declaration you refer to Schedule 1B of the Workplace Relations Act 1996.

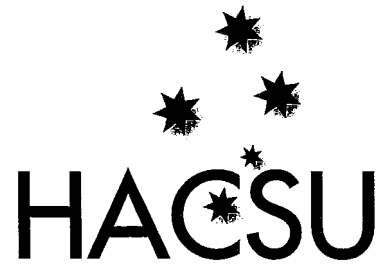
