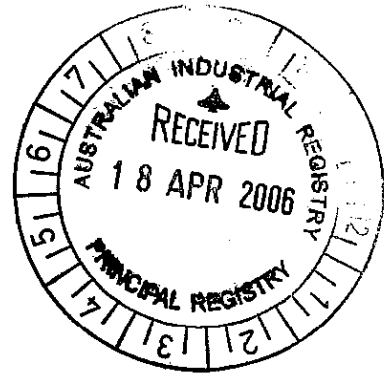
The meeting of the BCOM subsequently made the following appointments in accordance with the Union rules.
