

I refer to the letter from the Regulatory Compliance Branch dated 8 April 2013 in relation to the Declaration of the list of Offices and Office Holders in the Branch dated 12 February 2013 which was enclosed with the letter dated 12 February 2013.

Enclosed please find amended Notification of Change of Information and Declarations required under s 230 (1) (b) and s233 (2) of the *Fair Work (Registered Organisations) Act 2009*

The amended declaration of names, postal addresses and occupation of office holders in the Branch as at 12 February 2013 (enclosed) shows the vacant position of Vice President (Psychologist) following the resignation of the office holder on 5 February 2013. Notice of that resignation has been given to Fair Work Australia. I enclose an amended notification of this change.

I also give notice of the resignation of an office holder, (Committee Member, Psychologist), in March 2012. Notice is also given of the appointment of a person to fill that vacant office in May 2012.

Further, on 27 June 2012 I was appointed by the National Council to the vacant position of National Assistant Secretary of the Health Services Union, from 30 June 2012. 
