I acknowledge receipt on 29 August 2014 of a Notification from the Independent Education Union of Australia of changes to the Federal Executive following the completion of elections E2014/59 and E2014/165.

The Notification has not been filed as it does not meet the requirements of the *Fair Work (Registered Organisations) Act 2009* (the RO Act), set out below.

1. Section 233(2) of the RO Act requires that a notification of change to records kept by the organisation be certified by declaration signed by the secretary or other prescribed officer to be a correct statement of the changes made.
