Dear General Manager

I wish to advise that the declaration of the IEUA Ballot on 21 March 2014, E2014/59, revealed that one of the two Vice Presidents positions, pursuant to rule 18 of the IEUA Constitution, was unfilled.

Accordingly, I would request that a further ballot be called for the election of the unfilled Vice President position.

For the purposes of subsection 189(1) of the RAO Schedule and regulation 138, I provide the following information:

- (a) The office of one Vice President is the office in respect of which an election is required.
- (b) The election is required because the term of office expired in March 2014 and only one nomination was received for the two positions declared vacant in the election conducted E2014/59.
- (c) The IEUA would request that dates be set aside during August for the conduct of the ballot.
- (d) The electorate comprises the Federal Council. The rules provide the office as listed in (a) be elected by and from Federal Council.
- (e) The voting system to be employed in the conduct of the election is the collegiate electoral system.
