(b) the reason for the election is that the term of office is due to expire.

(c) As listed in (a) above

(d) The electorates for the five Vice-Presidents are as follows - one each elected respectively by and from:

(1) Members employed in NSW in early childhood services;

(2) Members employed in NSW in schools or as an adviser, supervisor or education officer by or under the supervision of a Catholic diocese but excluding members included in paragraph (d).

(3) Members employed in NSW in a school or educational institution other than an early childhood service or a school or educational institution under the supervision of a Catholic Diocese but excluding members included in sub-paragraph (d) of this paragraph;

(4) Members employed in NSW as school support staff, (including school secretaries, clerical assistants or school assistants); boarding house staff (other than teachers); grounds or maintenance staff; canteen staff and members in other related classifications.

(5) Members employed in the Australian Capital Territory

The electorate for the positions of Deputy President and alternate delegate to Federal Executive is the Branch Executive.

(e) The time frame proposed by the organisation and as required in the rules of the organization (see generally Federal Rule 17 and NSW/ACT Branch Rule 9) for all positions (except Deputy President and Alternate Delegate to Federal Executive) is as follows:

(i) Nominations to open from Tuesday 24 July 2007 and close 4 pm Tuesday 14 August 2007 (see Federal Rule 17(h) and Branch Rule 9.8 (b)).

(ii) The roll of voters shall close on 4 pm Monday 16 July 2007 (Federal Rule 17(q)).

(iii) The ballot to commence Wednesday 5 September and close noon Thursday 27 September 2007.

The elections for the positions of Deputy President and alternate delegate to Federal Executive, conducted by and from the Branch Executive, should be completed as soon as possible thereafter (Branch Rule 9.12).

(f) The voting system to be employed in the conduct of the elections for the Branch Executive and the Delegates to Federal Council is a direct voting system.

The voting system for the positions of Alternate Delegate to Federal Executive and Deputy President is collegiate.
