Re: Request for Conduct of Election

Assistant Secretary Independent Education Union of Australia - Queensland and Northern Territory Branch (IEUA-QNT)

In accordance with Chapter 7 Part 2 of the Fair Work (Registered Organisations) Act 2009, I provide the following prescribed information in accordance with the requirements of subsection 189(1).

Re Fair Work (Registered Organisations) Regulations 2009 – subsection 138(1)(a) and (c)

That in accordance with Rule 7.4 and Rule 11 of the Rules of the Independent Education Union of Australia Queensland and Northern Territory Branch (IEUA-QNT) an election is required for:

Assistant Secretary - One (1)

Re Fair Work (Registered Organisations) Regulations 2009 – subsection 138(1)(b)(iii)

This election is made necessary in that a second Assistant Secretary as a member of the Committee of Management has been created under an approved rule alteration [R2015/24]

Re Fair Work (Registered Organisations) Regulations 2009 – subsection 138(1)(d)

That in accordance with Rule 7.4 of the IEUA-QNT Branch Rules, members of the Branch Executive shall elect by and from the Branch Executive a Committee of Management.

Re Fair Work (Registered Organisations) Regulations 2009 subsection 138(1)(e)

Rule 11 of the Branch Rules is relevant and determines the process of nomination and election.

In setting dates for the election process Branch Transitional Rule 20.11 determines that this election shall conclude no later than three (3) months from the date of approval of the rule alteration which created the additional Assistant Secretary position. The rule alteration [R2015/24] was approved on 27 February 2015.

Re Fair Work (Registered Organisations) Regulations 2009 – subsection 138(1)(f)

That in accordance with Rule 17(q) of the Federal Rules of the IEUA, the books of the Branch shall be deemed to have closed as at seven (7) clear days before the opening date of the nominations.

Re Fair Work (Registered Organisations) Regulations 2009 – subsection 138(1)(g)

Branch rule 11 provides that a collegiate electoral system shall operate in the election of a member of the Committee of Management.

The electorate for the election is 30 persons being the current total of members of the Branch Executive. Four (4) vacancies exist to be filled as casual vacancies.

Federal Rule 17(v) provides for a preferential voting system.
