The documents lodged also include a declaration by Ms Howe. The declaration states that a register of members has been kept for the year 2006. This should read 2007.


A list of offices is required to be lodged. Whilst the declaration includes a list of office holders, there is no list of offices in the Branch.

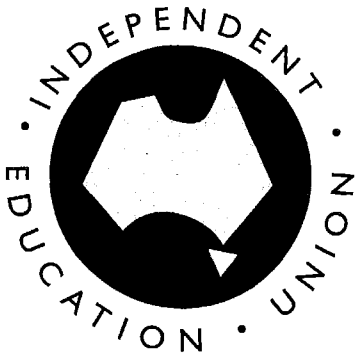

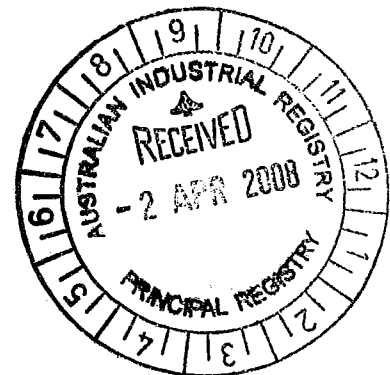

**STATEMENT CONCERNING NUMBER OF MEMBERS**

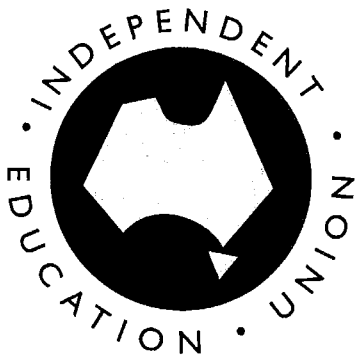
