PRESCRIBED INFORMATION

- (a) An election is required in respect of:
 - (i) Secretary
 - (ii) Eleven (11) Ordinary Members of the Branch Executive
 - (iii) Three (3) Delegates to Federal Council.
- (b) The reason for the election being held is that the term of office is due to expire in the normal course of events under the rules of the organisation.
- (c) There is an entitlement (under Federal Rule 8c) to three (3) Delegates to Federal Council, there being 3334 financial members in this Branch.
- (d) The electorate comprises only members of the IEU(SA) Branch.
- (e) The date for opening of nominations is on or about 30 July 2007 and the closing of nominations is on or about 20 August 2007 (in accordance with Federal Rule 17).
- (f) The voting system to be employed is a direct voting system.

AND IMMEDIATELY THEREAFTER

- (a) An election is required in respect of additional Branch Officers, such officers being:
 - (i) President
 - (ii) Two (2) Vice-Presidents
 - (iii) Treasurer
 - (iv) Alternate Delegate to Federal Executive.
- (b) The reason for the election being that the term of office is due to expire in the normal course of events under the rules of the organisation.
- (c) There are two Vice-Presidents to be elected.
- (d) The electorate comprises the elected members of the Branch Executive.
- (e) The date for opening of nominations will coincide with the declaration of the poll for the election of members of the Branch Executive which, if an election is required, will be on or about 1 October 2007.
- (f) The voting system to be employed is a collegiate electoral system.
