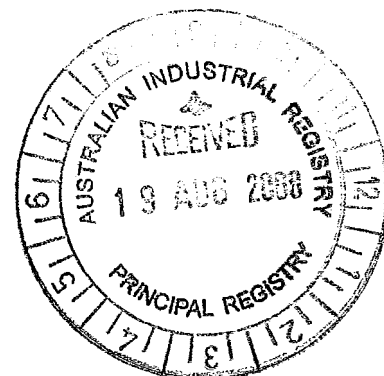

Please find enclosed the prescribed information for elections concerning the Independent Education Union (South Australia) Branch, a Branch of the Independent Education Union of Australia.



- (a) An election is required for 2 casual vacancies in respect of:
